The east half of the north west quarter of the south east quarter of section four in township six south of range three east of St Stephens Meridian, containing twenty acres, more or less. And the said Aaron Harford and Fred Harford, party of the first part, for themselves their heirs, executors and administrators, do covenant promise and agree to and with the said party of the second part, his heirs and assigns, that they have not done, or suffered to be done whything whereby the said premises hereby granted are, or may be, in any manner encumbered or charged; and that the said premises against all persons lawfully claiming, or to claim the same, by through or under them will warrant and forever defend. And the said party of the first part, hereby expressly waive and release any and all right benefit, privilege and ad antage, and exemption under or by virtue of any and all statutes of the state of Alabama providing for the exemption of homesteads from sale on execution or otherwise.
