DEED WITH WARRANTY.

(W/d) THIS DEED made the 28th day of March, 1925, between Oscar Johnson and Josephina Johnson his wife, of Silverhill, Baldwin County, Alabama, of the first part and State Bank of Silverhill, Baldwin County, Alabama, of the second part,
